Background: In collaboration with the Sonoma arts community, including VAPA teachers, Creative Bridges and other art partners, and with support from the Board of Education, Sonoma Valley Unified School District has developed a Strategic Arts Plan to bolster a comprehensive TK-12 visual and performing arts program (Refer to the BOE meeting dated November 9, 2023). In the initial years of Prop 28 funding, the primary goal is to enhance arts education at the elementary school level, providing all TK-5 students with a robust foundation in visual arts and music with the intention to expand the secondary VAPA program over the next 2-3 years. Moreover, we intend to allocate 1% of administrative expenses (up to the maximum amount) to facilitate a TK-12 VAPA lead for the district.

Funding Requirements:

- 80% Certificated and Classified Salaries
- 20% Arts Education Costs (equipment, training, materials)

Elementary School

This is the combined Elementary Plan for Prop 28 Arts and Music Schools with all SVUSD elementary schools "pooling" their AMS funding to support a comprehensive VAPA program.

To supplement the existing elementary arts curriculum over time, the envisioned plan involves utilizing future Prop 28 funds to employ the following personnel: 1.0 FTE itinerant music teacher, 1.0 FTE itinerant visual arts teacher, and 1.0 FTE itinerant drama teacher, to be shared among the four elementary schools.

2023-2024 Baseline Year

For the 2023-2024 school year, SVUSD allocated 1.0 FTE itinerant music and 1.0 FTE itinerant visual arts positions to serve four elementary schools. Students receive 45 minutes of 1 semester visual art instruction and 1 semester music instruction.

2024-2025 VAPA Offerings

For the upcoming 2024-2025 school year, the plan entails hiring an additional 1.0 elementary music teacher under Prop 29 funding to supplement the current offering. We are also collaborating with Save the Music Intro to Music Grant to provide musical instruments at Sassarini and El Verano to offer a comprehensive general music program for our young musicians in TK-5 year long.

Materials and supplies:

19% of the funding may cover expenses such as instruments, sheet music, music stands, storage, art supplies, field trips, training, arts educational programs and guest speakers.1% of the funding may be allocated for a district VAPA lead stipend.
