All students will be assigned to a bus stop, receive a bus pass, and display the pass for every boarding. Bus passes are Non-Transferable and forgery or duplicate use of a bus pass will result in expulsion from the school bus. Passes need to be presented to the driver upon boarding the bus for each ride. If pass is damaged or lost, any replacement will incur a \$10.00 or \$15.00 charge. All students are responsible to follow the rules listed below. These rules will ensure safe and proper travel to and from school and are to be observed while waiting at bus stops, riding the bus home and to school, or on field trips. **SVUSD Bus Safety Rules:** I have received, Read and understand the rules and regulations for bus riders as well as bus policy. Failure to do so may cause refusal of transportation to the student. I agree that my student will follow all rules and regulations for the SVUSD Transportation Dept. Be respectful to other riders, the bus driver, people who are not on the bus, property, and yourself. Only Registered riders shall ride the bus. DO NOT invite friends to ride with you.
